BY-LAW #2009 – 20

**BEING a by-law to appoint Township Officials and
Committees and to affix their salaries where necessary.**

WHEREAS it is deemed necessary to appoint certain Township Officials and Committees for the purpose of carrying out the business of the municipality for the year 2009 and in accordance with the provisions of the Municipal Act of the Province of Ontario;

NOW THEREFORE THE COUNCIL OF THE TOWNSHIP OF EAST ZORRA-TAVISTOCK ENACTS AS FOLLOWS:
